# Dark Money: The Hidden History of the Billionaires Behind the Rise of the Radical Right

«We must make our choice. We may have democracy, or we may have wealth concentrated in the hands of a few, but we can't have both.» - Louis Brandeis

Jane Mayer spent five years researching this book. At a time when economic inequality is reaching a peak in America, she has focused on the Koch brothers, Charles and David, and their network of extremely wealthy people who fear socialism and are dedicated to a libertarian view of minimal government. They are opposed to nearly all regulations, to income taxes, to any form of welfare, and even the Food and Drug Administration. They seem to believe that the only legitimate function of government is to provide security and enforce property rights. The brothers were vehemently opposed to government taking any action on climate change that would hurt their fossil fuel profits. Between 2003 and 2010, they spent over half a billion dollars on a massive campaign to manipulate and mislead the public about the threat posed by climate change. Meanwhile, Koch Industries continued to be the number one producer of toxic waste in the US and one of the largest emitters of greenhouse gases.

There seems to be a common view among the wealthy that people are poor because they made poor choices or didn't work hard enough. What kind of understanding would the Koch brothers have of ordinary people when their own father, Fred, was the richest man in Kansas when he died?

The most insidious thing about the way these people have used their wealth is all the ways they have sought to influence our way of life. In 2012, following *Citizens United*, outside spending groups spent more than a billion dollars to influence federal elections. The Democrats lost sixty-three seats in the House that November.

And there influence didn't stop there. The Charles Koch Foundation managed to build a "Freedom - Advancing Network" of nearly five thousand scholars in some four hundred colleges and universities across the country, resulting in altering faculty views toward the right and in some cases even teaching the philosophy of Ayn Rand.

The Koch brothers were also directing millions of dollars into online education in high schools, teaching students in some cities that Franklin Roosevelt didn't alleviate the Depression, that minimum wage laws hurt the poor, and that lower pay for women was not discriminatory.

After reading this book, I am convinced that we no longer have a functioning democracy. Does anybody care? That is the question. When two unelected multi billionaires can control enough of the US government and our educational systems to determine what is best for the other 330 million of us, surely we have a crisis.

Economic inequality and the influence of money in politics have been the top issues in Bernie Sanders's campaign, and I hope the Democratic Party will continue to prioritize those issues until we can find a way to bring about some meaningful changes.

#### Robert Winsor

July 26, 1928 – June 12, 2016

Judge Robert Winsor, the last surviving founding member of the Metropolitan Democratic of Seattle, died June 12, 2016. He served as treasurer of the organization in 1967 and 1968.

Mr Winsor earned his undergraduate and law degrees from the University of Minnesota. He worked for five decades as a lawyer, judge, mediator and arbritator and also served as a board member of the ACLU, was appointed by Governor Dan Evans as a trial judge for the King County Superior Court; later served on the Court of Appeals; worked with the Seattle's Judicial Arbitration and Mediation Services; and was appointed by Governors Mike Lowry, Gary Locke and Christine Gregoire to the state Clemency and Pardons Board. After his retirement, he re-joined the MDC.
