School achievement gaps not improving

Achievement gaps in proficiency in math and English language arts in Seattle Public Schools are not closing according to Seattle School Board Directors Jill Geary and Eden Mack. Both addressed the November 14 meeting of the Metropolitan Democratic Club of Seattle.

They distributed charts that showed 81 percent of white students and only 33 percent of black/African American students met the standard in mathematics for 2016-17. In English language arts the percentages were 85 and 35 respectively.

However, Ms Geary said, the Seattle Public Schools continues to improve overall student achievement compared to the state as a whole. SPS students outperform the state average by 12 points in math and 10 points in English language arts. Graduation rates, she added are at an all time high of 82 percent.

The educational programs and operations (EP&0) levy that will appear on the ballot next February is intended to bridge the gap between what the state funds and what Seattle students need, explained Ms Mack, and the capital levy (BEX V) is used to replace or modernize school buildings. The levies are asking for an increase in property taxes of \$1.95 per \$1,000 assessed home value.

Open Borders A personal story of love, loss and anti-war activism



I am privileged to know and to have become good friends with Betsy Bell for several years. She has shared with me the adventure of writing this book. Now it is so wonderful to read it. The book begins with her experience of going to Tashkent and is very exciting to read. Many of us remember the Target Seattle adventure in the 80s. Betsy describes it in personal detail. The adventure of course started in Kay Bullitt's living room. Kay also went on this journey. The book describes not only this journey in emotional detail, but all of the events that happened afterwards including her journey to Congress and the United Nations. It also expresses her personal emotions and the tragic event of the death of her husband Don.

Betsy is still very involved in political issues. She is the personification of a political activist. The trip had a major positive effect in Seattle. Bob Walsh joined Target Seattle in 1985 and put together the Goodwill games in 1990 representing Ted Turner. The significance of the trip to Tashkent and the Goodwill games cannot be underestimated. The people in Seattle created a significant atmosphere to stop the hostility between United States and the Soviet Union. As we might remember, in addition to the Goodwill games, the opera, ballet, and repertory theater all put on Russian performances. Bob died last year of the flu in Istanbul after being airlifted from Georgia Russia.

My only personal disappointment is that I was not on that trip.

Critic asserts we must transition to a new economy

Dr David Korten is not optimistic about our future

"We are on a path to self-extermination," he told members and friends of the Metropolitan Democratic Club of Seattle at its October 24 meeting. A leading critic of what he calls global suicide economy, he believes humanity is on a route to destroy the earth's ability to support life and must transition to a new economy.

Corporate control of government is increasing, Mr Korten asserted, and as corporations are restricted to maximizing financial returns, next quarter's profits are all that matter to them; they do not have an incentive to preserve an asset for the sustained long run.

The result is that people are disconnected; they lack support from the community, he said. Corporate agriculture supports privatization of the commons, driving people off the land, causing them to lose control

Crittenden: win in 2020 to achieve Medicare for all

"I saw four people die because they had no insurance," Dr Bob Crittenden told members and guests of the Metropolitan Democratic Club of Seattle at its October 10 meeting. That was before Obamacare, he added.

Mr Crittenden is a professor emeritus in the Departments of Family Medicine and Health Services at the University of Washington. He also served as Governor Jay Inslee's special assistant for health reform and senior policy advisor on health care, 2013 – 2018.

In addition, he is founding executive director of the Herndon Alliance, a coalition of more than 200 organizations nationally doing communications for passage and preservation of the Affordable Care Act.

Mr Crittenden explained that research shows that people like the protection of the Affordable Care Act. They want to keep what they have, they want more access, and no more taxes. About 92 percent don't want government-run health care. Those who oppose the Affordable Care Act fear that health care will double their taxes, health

of their environment and making them dependent on a monetized economy, in effect making them dependent on an employer or a bank. In the process, they are undermining mandatory essential relationships.

"We need a commons that people can fall back on when their earning or other resources are insufficient to support their livelihoods," he said. We need to break up the transnational corporations and change the legal systems around them to give them an incentive to preserve resources and not destroy peoples' habitats.

Mr Korten claimed that maintenance of the commons and a sense of connection is an issue of particular interest to the younger generation. He suggests the younger generation can be shaped into a political force to mitigate corporate control of the human environment.

Mr Korten is founder and president of the Living Economics Forum and has written several books that frame a new economy, including *Change the Story, Change the Future, Agenda for a New Economy,* and *When Corporations Rule the World.* He holds a PhD from Stanford University and served five years on the faculty of the Harvard Business School. care services will be government-run, that they will have to change coverage (they equate choice with quality), and that Medicare will be turned into something else.

How do we (and those running for office) address these perceptions, Mr Crittenden asked? We stress Medicare for all, build on the ACA, and don't bad-mouth the opposition. We have to do this and we have to win in 2020, he said.

The most powerful argument that will help us connect with the American people is pre-existing conditions. Others are affordability, reducing the cost of drugs and increasing protection.

What would he do to improve the ACA? Work on universal coverage and negotiating pharmaceuticals. Right now, he said, the United States ranks 32nd in the world in terms of health outcomes.
